Michael Duncan should be recalled from office of Mayor of the Town of Johnstown, Colorado for exceeding his authority under the Town Charter, and undermining transparency in Town governance.

On September 3, 2025, Mr. Duncan proposed positioning Johnstown as a hub for artificial intelligence data centers and introduced Russ Baca as the newly created Chief AI Business Development Officer, tasked with procuring land for a data center. Mr. Duncan disclosed that he met privately with outside consultants he did not identify to develop this initiative, without Council's knowledge and without issuing a Request for Proposal. Council members stated they were not informed of these meetings. Following discussion, including Mr. Baca's acknowledgment of limited relevant experience, Council voted five to one to reject the agreement, with Mr. Duncan casting the sole dissenting vote.

Despite this rejection, Mr. Duncan wrote in the December 1, 2025, Johnstown Lowdown that the Town was working to make Johnstown a regional center for innovation and technology through AI infrastructure development. On July 13, 2026, he again directed staff to prepare a data center concept despite Council's prior denial.

These actions reflect a pattern of acting outside Charter authority and bypassing established Council processes.
